# RULES AND REGULATIONS OF REGISTRATION FOR THE STATE OF BLOCKCHAIN CONFERENCE

## I. General provisions

1. The "THE STATE OF BLOCKCHAIN" Conference (hereinafter: THE STATE OF BLOCKCHAIN or Conference) on blockchain technology, to be held on 01-02 December 2025 is organized by Naukowa i Akademicka Sieć Komputerowa – Państwowy Instytut Badawczy (hereinafter: NASK-PIB) with its registered office in Warsaw and place of business at the address: Kolska 12, 01-045 Warsaw, whose register files are kept by the District Court for the capital city of Warsaw, 13th Commercial Division for the National Court Register (KRS), under No. 0000012938, tax identification number NIP: 521-04-17- 157.

1. These rules and regulations (hereinafter: Regulations) define the rules concerning registration to attend the Conference.

2. NASK is organizing the Conference with the participation of Cybersecurity Systems Development Department and is responsible for its substantive, organizational and advertising aspects.

## III. Personal data protection

### 1. The controller of THE STATE OF BLOCKCHAIN
